Water & Sewer Users Agreement Terms

This agreement between the Wetumpka Water Works and Sewer Board of the City of Wetumpka, a public corporation organized and existing under the laws of the State of Alabama, hereinafter called the "Corporation", and the undersigned water and sewer user, hereafter called the "User".

Witnesseth: That, whereas, the User desires to purchase water for domestic, commercial, agricultural, industrial or other uses and as available, to obtain sanitary sewer service, from the Corporation and to enter into a Users Agreement as required by the By-laws of the Corporation.

Now, therefore, in consideration of the mutual covenants, promises and agreements herein contained. It is hereby understood and agreed.

1. The Corporation shall furnish, subject to the limitations as provided for the By-laws and Service Rules and Regulations hereinafter provided for, such quantity of water as the User may desire in connection with his occupancy of property located within the extremes of the Corporation are, and as available, sanitary sewer service to said property.
2. The User shall install and maintain at his expense service lines which shall begin at the point designated by the Corporation at this property line / ROW and extend to the dwelling and other portions of his premises.
3. The User's service lines shall connect with the water and/or sanitary sewer systems of the Corporation at the place designated by the Corporation, provided the Corporation has determined in advance that the Corporation's water and/or sanitary sewer systems are of sufficient capacity to service the User's property.
4. The User shall pay for such service at such rates, times and place as shall be determined by the Corporation. The Corporation reserves the right to report all unpaid charges and fees to any credit report agency or collections bureau. The User accepts the fee charged as a lawful debt and promises to pay said fee including the cost of collection, attorney fees, and court costs if such be necessary, waiving now and forever the right to claim exemption under the constitution and laws of the State of Alabama, or any other state.
5. The Corporation shall make the final determination in any questions of location of any service line connection to its water or sanitary sewer system and shall determine the allocation of water to Users in the event of a water shortage.
6. The Corporation may shut off the water and/or sewer service of a User who allows a connection or extension to be made to his service for purpose of supplying water or sanitary sewer service to another user.
7. The user shall make the water meter accessible and unobstructed at all times to the Corporation and the User shall install a cut-off valve and pressure regulator on the User's side of the meter. The Corporation shall install a lockable cutoff valve on the supply side for the sole use of the Corporation.

TAMPERING FEES

At its regularly scheduled Board Meeting on October 27th, 2016, the Board approved the following Tampering fees:

First Offense:	\$150.00
Second Offense:	\$300.00
Third Offense:	\$500.00

This includes cut locks, unauthorized connections and alterations, damages to meter or box and bypassing the meter.



(Effective May 1, 2009)

Irrigation / Swimming Pool Meters

The Wetumpka Water Works and Sewer Board will set an additional water meter, to be used strictly for watering lawns, landscape or maintaining swimming pools, for a fee of \$300.00 for a $\frac{3}{4}$ inch meter or \$450.00 for a 1 inch meter. The fee must be paid before the meter is installed. The irrigation meter will not be tapped onto our main. It will connect to the service line before the existing household meter. You may not have the same pressure that you currently have when using your irrigation, i.e. garden hoses etc.

Should the customer desire a totally separate connection for irrigation and /or swimming pool, a separate tap on the main will be \$1,500.00 for a $\frac{3}{4}$ inch meter/service. There will be a \$100.00 non-refundable account initiation fee, as required for all other meters, but you will not be charged a monthly minimum bill on this non-household meter. The customer will be billed for the actual water usage on this meter. The water rate will be the same as the current residential rate.

No sewer fees will be associated with the irrigation meter. The meter is strictly prohibited for any other purpose and cannot be connected to any dwelling for household use. Any violation will result in penalty fee of not less than \$500.00 for the first offense, and a second offense will result in the removal of the meter and additional fines.
